RESOLUTION NO. SP-3073, S-2005 (PR2005-379/PR2005-378)

A RESOLUTION RENEWING THE SPECIAL PERMIT GRANTED TO UNIPROM, INC., TO HOLD TWENTY (20) LOCAL AND INTERNATIONAL DERBIES AT ARANETA COLISEUM ANNUALLY FOR FIVE (5) YEARS, SUBJECT TO THE PROVISIONS OF EXISTING LAWS, ORDINANCES, RULES AND REGULATIONS AND THE PAYMENT OF TAXES, FEES AND OTHER CHARGES.

Introduced by Councilors VICTOR V. FERRER, JR., and RESTITUTO B. MALANGEN.

WHEREAS, Uniprom, Inc., was granted a special permit to hold Local and International Derbies at Araneta Annually for five (5) years by virtue of Quezon City Council Resolution No. SP-1441 adopted on September 12, 2000;

WHEREAS, Araneta Coliseum was granted a permit as a cockpit by virtue of Resolution No. NC-502, S-90 and SP-1475, S-2000;

WHEREAS, the renewal of the Special Permit to Uniprom, Inc., to hold twenty (20) Local and International Derbies at the Araneta Coliseum annually, will entail continued payment of Taxes, Fees and other charges to the City government albeit the attraction of tourists that these games may bring;

WHEREAS, there is a need to renew the said special permit to comply with the requirements of existing laws, ordinances and other issuances.
