WHEREAS, the City government of Quezon City is fully aware of the growing number of residents in Quezon City which should be readily addressed to avoid future predicaments in land management and development;

WHEREAS, Quezon City has become highly urbanized such that it has multiplied its population for the past years to a gigantic proportion leaving some of the public services critically inadequate to meet the present needs and condition of its constituents;

WHEREAS, with the continuous increase of the population, private and public cemeteries may no longer accommodate the growing number of deceased citizens of the City prompting them to create an alternative measure to contain such number;
