A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON THE 27TH OF AUGUST 2005 AT BARANGAY ESCOPA III, PROJECT 4, QUEZON CITY, AND FURTHER AUTHORIZING HIM TO ALLOCATE AND DISBURSE SUCH FINANCIAL AID AS SPECIFIED HEREIN FROM WHATEVER FUNDS OF THE CITY GOVERNMENT WHICH MAY BE AVAILABLE.


Introduced by Councilor FRANZ S. PUMAREN, JORGE B. BANAL, JR., WENCEROM BENEDICT C. LAGUMBAY, DANTE M. DE GUZMAN, JULIAN M.L. COSETENG and DIORELLA MARIA SOTTO-DE LEON.

WHEREAS, on the 27th of August this year, a conflagration broke out in Barangay Escopa III, Project 4, Quezon City and affected a number of families therein, some resulting in a total loss of their homes;

WHEREAS, we, as their representatives and protectors, in accordance with the time honored principle of parens patriae, must do our part to ensure that they receive any bit of assistance that we could give them.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor to extend financial assistance to those deserving victims as may be determined by the Social Services and Development Department in the amount of Two Thousand Pesos (P2,000.00) for every house owner and One Thousand Pesos (P1,000.00) for every house renter or sharer.

RESOLVED, FURTHER, that the Social Services and Development Department shall determine through the proper procedure, those who were truly affected by the conflagration and thereby worthy of receiving assistance.

RESOLVED, FINALLY, that the City Mayor is hereby authorized to allocate whatever amount as may be necessary for purposes of this measure and release such allocation from whatever fund from the City Treasury that may be available.
