A RESOLUTION URGING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO IMMEDIATELY DIRECT PROPER AGENCIES CONCERNED TO INSPECT AND THEREAFTER TO CAUSE THE NECESSARY REPAIR, RE-WIRE AND POSSIBLE INSTALLATION OF NEW WIRINGS ON ALL EXISTING DEPRESSED AREAS ELECTRIFICATION PROGRAM (DAEP) MAIN CONTROL SWITCH CONNECTIONS IN THE CITY.

WHEREAS, there is now the ever-increasing in number of request for immediate repair, re-wire, installation of new wirings from Quezon City residents living in areas where the main electrical source of services are generated thru the then Depressed Areas Electrification Program (DAEP) as effected by the National Power Corporation;

WHEREAS, the main reason for such urgent request is attributable to the fact that the wirings, connections and other safety nets in the main switch control of the DAEP are posing dangers to life and limb as well as to the property of all DAEP beneficiaries as its quality is now at almost full state of deterioration;

WHEREAS, experts on the matter are convinced that at anytime, if not properly attended to, fires may break out due to short circuit as created by these unsafe wirings and connections in almost all DAEP main line and switch of operations;

WHEREAS, these DAEP are at present may be found in almost all depressed areas of Quezon City and residents have no personal and individual capacities to shoulder from their own resources the needed funds required to repair, re-wire or install new wirings on the main switch control of the DAEP.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, His Honor, Mayor Feliciano R. Belmonte, Jr., to immediately direct proper agencies concerned to inspect and thereafter to cause the necessary repair, rewire and possible installation of new wirings on all existing depressed areas electrification program (DAEP) main control switch connections in the city.
