A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE, JR., TO ALLOW THE CREATION OF A SECTION UNDER THE BIDS AND AWARDS COMMITTEE (BAC) WHICH WILL EXCLUSIVELY MANAGE THE LEGISLATIVE ACCOUNTS.

WHEREAS, Section 11 of R.A. 1984 otherwise known as the "Government Procurement Reform Act" provides that "alternatively as may be deemed fit by the head of the procuring entity, there may be a separate BACs where the number and complexity of the items to be procured shall so warrant. Similar BACs for decentralized and lower level offices may be formed when deemed necessary by the head of the procuring entity";

WHEREAS, it has been observed that the procedures in the present BAC has been a time consuming process;

WHEREAS, it is high time that such protracted procedure be remedied by creating a section which will be under the supervision of the BAC for the purpose of aiding the BAC and for the purpose of systematizing the procurement process of the legislative accounts.


