A RESOLUTION REQUESTING THE ASSISTANCE OF HONORABLE SENATOR JUAN M. FLAVIER TO PROVIDE THE FUNDS FOR THE CONSTRUCTION OF A FIFTEEN (15) CLASSROOM SECONDARY SCHOOL BUILDING IN BARANGAY KAUNLARAN (PONCIANO BERNARDO HIGH SCHOOL) WORTH TEN MILLION PESOS (P10,000,000.00) TO BE TAKEN FROM THE SENATOR'S COUNTRYWIDE DEVELOPMENT FUND.
