RESOLUTION NO. SP. 4989 S-2010

A RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO A CONTRACT WITH FERMINA S. OVIEDO FOR THE PURCHASE OF A CERTAIN PARCEL OF LAND, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-224682 OF THE REGISTRY OF DEEDS OF QUEZON CITY LOCATED AT MOLAVE STREET, BARANGAY PAYATAS, QUEZON CITY, TO BE UTILIZED FOR VARIOUS DEVELOPMENT PROJECTS LIKE SOCIALIZED HOUSING, ROADS, SCHOOLS AND OTHER INFRASTRUCTURES.

WHEREAS, the city intends to acquire a certain parcel of land identified as Lot 9-B, Psd-00-036995 registered in the name of Fermina S. Oviedo, covered by Transfer Certificate of Title No. N-224682 of the Registry of Deeds of Quezon City located at Movale St., Barangay Payatas, Quezon City, to be utilized for various development projects like socialized housing, roads, schools and other infrastructures;
