WHEREAS, the said event falls within the allowable activities exempted by the Quezon City Revenue Code considering that the proceeds of the event will go to the "Tahanan ng mga Ina ng Guadalupe";

WHEREAS, the "Tahanan ng mga Ina ng Guadalupe" is a home-care for the abandoned and underpriviledge grandmothers.
