



WHEREAS, it is but proper to turn over the ownership of these vehicles to the recipients so that these city-owned properties maybe transferred to them without cost;

WHEREAS, a Deed of Donation will be given to the beneficiaries transferring the ownership, encumbrances and dues of the said vehicles thereby authorizing them to appropriate funds for the payment of insurance and registration of the said vehicles from their respective budgets.





NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate the thirty eight (38) units of Suzuki APV Vehicles to the aforementioned recipients within District IV of Quezon City;

RESOLVED, FURTHER, that ownership of the said vehicles be transferred to the recipients through a Deed of Donation to be signed by the City Mayor Herbert M. Bautista, Councilor Jesus "Bong" C. Suntay as the main proponent and the Office of the City General Services Office (CGSO) represented by Mr. Rolando P. Montiel:

RESOLVED, FURTHERMORE, that the recipients be authorized to appropriate funds for the payment of insurance and registration of these vehicles from their respective budgets;

RESOLVED, FINALLY, that copies of this Resolution along with the Deed of Donation be given to the thirty eight (38) recipients, the Office of the City Mayor, the City General Services Office and the Office of Councilor Bong Suntay for future reference.
