A RESOLUTION APPEALING TO THE PRESIDENT OF THE UNIVERSITY OF THE PHILIPPINES TO ALLOT AT LEAST FIFTY (50) SCHOLARSHIP SLOTS FOR EVERY SCHOOL YEAR FOR THE POOR BUT DESERVING STUDENTS WHO ARE RESIDENTS AND GRADUATES OF PUBLIC HIGH SCHOOLS IN QUEZON CITY SUBJECT HOWEVER TO THE STATE UNIVERSITY'S SCHOLARSHIP REQUIREMENTS.



RESOLVED, FURTHER, that the President of the University of the Philippines, the Office of the Schools Division Superintendent of Quezon City, the Office of the City Mayor, the Public High School Principals and the 142 Barangays of Quezon City shall be furnished with copies of this resolution for their information and appropriate action.


