RESOLUTION NO. SP. 5057, S-2011

A RESOLUTION MANDATING THE ENVIRONMENTAL PROTECTION AND WASTE MANAGEMENT DEPARTMENT (EPWMD) TO REQUIRE ALL PRIVATE GARBAGE COLLECTION CONTRACTORS OF QUEZON CITY TO PROVIDE THEIR GARBAGE COLLECTION PERSONNEL WITH PROPER COVER-ALL UNIFORMS AND BODY PROTECTION GEARS.

WHEREAS, the general population does not generally acknowledge the important role that garbage collection personnel play in our everyday lives;

WHEREAS, it has been observed that garbage collection personnel of private garbage collection contractors are collecting garbage with their bare hands and usually are wearing short pants, t-shirts and rubber slippers. Handling waste can lead to an increased risk for contracting many serious illness, such as hepatitis or infections;

WHEREAS, without proper uniform and body protection gears, the health of these garbage collection personnel are being exposed to germs and bacteria when performing their duties of collecting garbage;

WHEREAS, garbage collection personnel face extremely dangerous work conditions. Their jobs involve maneuvering around huge trucks, lifting heavy loads, operating compacting machines, and handling potentially dangerous waste materials. There is therefore a need to protect the physical health of these garbage collection personnel who are prone to acquire contagious disease due to the nature of their work.
