**A RESOLUTION URGING THE QUEZON CITY GOVERNMENT TO STUDY, FORMULATE AND EMBARK ON AN ENVIRONMENTAL PROJECT TO CONSIDER THE POSSIBILITIES OF HARNESSING WASTE VEGETABLE OIL (WVO) AS AN ALTERNATIVE TO DIESEL FUEL IN GOVERNMENT VEHICLES TO REDUCE AIR POLLUTION AND MITIGATE CLIMATE CHANGE.**

*WHEREAS, biodiesel may be sourced by recycling the waste cooking oil generated by the restaurants industry and other dining establishments particularly the industrial deep fryers of fast food establishments;*

*WHEREAS, for the reasons above, the City government is of the belief that maximizing this readily available source of biodiesel will create significant impacts in improving air quality and mitigating air pollution and climate change.*

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Quezon City Government to study, formulate and embark on an environmental project to consider the possibilities of harnessing Waste Vegetable Oil (WVO) as an alternative to diesel fuel in government vehicles to reduce air pollution and mitigate climate change.

RESOLVED, FURTHER, that the Environmental Protection and Waste Management Department (EPWMD) of Quezon City shall be tasked to draw up and prepare an Integrated and Comprehensive Management Plan for the harnessing of Waste Vegetable Oil (WVO), as an alternative fuel, and undertake the proper implementation thereof.


