RESOLUTION NO. SP- 5064, S-2011

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO SIGN THE SOLID WASTE MANAGEMENT FACILITY AGREEMENT FOR AND IN BEHALF OF THE QUEZON CITY GOVERNMENT WITH THE IPM ENVIRONMENTAL SERVICES, INC. REPRESENTED BY ITS PRESIDENT, ISABELITA PAREDES MERCADO ON THE PROVISION OF AN INTEGRATED SOLID WASTE MANAGEMENT FACILITY IN THE AMOUNT OF FOUR HUNDRED EIGHTY ONE MILLION SEVEN HUNDRED NINETY SEVEN THOUSAND NINETY FIVE PESOS AND SIXTY FOUR CENTAVOS (P 481,797,095.64) ANNUALLY.

WHEREAS, the City has been disposing its solid waste into the Payatas Controlled Disposal Facility, a controlled dump site proscribed under Republic Act No 9003, otherwise known as the "Ecological Solid Waste Management Act of 2002.";

WHEREAS, a Closure Order was issued by the Department of Environment and Natural Resources in the Year 2006 which resulted in the crafting of the Final Closure Plan converting, rehabilitating and operating the Payatas Controlled Disposal Facility until it is finally shut down;

WHEREAS, due to the complete closure of the existing solid waste disposal facility on 31 December 2010, it is imperative for the City to commission a new facility that will accommodate the processing and disposal of an estimated 1,200 tons of solid waste generated daily over the 16,000-hectare expanse of the City;

WHEREAS, the Quezon City Government is mandated to establish an efficient, Solid Waste Management Facility under a comprehensive environment management program pursuant to Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, on 22 November 2010, the Bids and Awards Committee (BAC) invited the public to a competitive bidding for the provision of an Integrated Solid Waste Management Facility which consist of:

- (1) Engineered Sanitary Landfill;*
- (2) Materials Recovery And Processing Facility (MRPF); and*
- (3) Maintenance and Post-Closure Care Service of the Payatas Controlled Disposal Facility;*

wherein interested bidders are required to provide a readily available solid waste disposal facility that can accommodate solid waste collection of the City after 31 December 2010;





WHEREAS, upon compliance with the prescribed requirements under Republic Act No 9184, otherwise known as the "Government Procurement Reform Act" and it's Implementing Rules and Regulations, the said project was awarded to IPM Environment Services, Inc. being the single calculated and responsive bidder;

WHEREAS, owing to the necessity of having a new solid waste management facility effective 01 January 2011, the Honorable City Mayor Herbert M. Bautista is required to enter into a Solid Waste Management Facility Agreement, for and in behalf of the Quezon City Government, with IPM Environment Services, Inc for the provision of Integrated Solid Waste Management Facility;

WHEREAS, the cost of the establishment of the Integrated Solid Waste Management Facility shall be shared by the Quezon City Government and the Metropolitan Manila Development Authority (MMDA) at Forty Percent (40%) and Sixty Percent (60%), respectively, as provided for under Section 14 of Ordinance No SP-2030, S-2010;

WHEREAS, the said agreement is effective for a period of three (3) years commencing on 01 January 2011 to 31 December 2013, subject to the annual evaluation by the Quezon City Government to determine compliance of IPM Environment Services, Inc. with the terms and conditions stipulated therein;

WHEREAS, Republic Act No 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations provides that the City Mayor shall represent the city in all its transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinances.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to sign the Solid Waste Management Facility Agreement for and in behalf of the Quezon City Government with the IPM Environment Services, Inc represented by its President, Isabelita Paredes Mercado on the provision of an Integrated Solid Waste Management Facility in the amount of Four Hundred Eighty One Million Seven Hundred Ninety Seven Thousand Ninety Five Pesos and Sixty Four Centavos (P 481,797,095.64) annually.
