RESOLUTION NO. SP- 5066, S-2011

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A DEED OF DONATION FOR THE DONATION OF THIRTEEN (13) CITY-OWNED AIRCONDITIONING UNITS PURCHASED UNDER THE FUNDS OF COUNCILOR JESUS MANUEL C. SUNTAY, TO DIFFERENT BARANGAYS, PUBLIC SCHOOLS, POLICE STATIONS AND HEALTH CENTERS WITHIN DISTRICT IV, THIS CITY, AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAID EQUIPMENT TO THE RECIPIENTS WITHOUT COST.

Introduced by Councilors JESUS MANUEL C. SUNTAY, EDCCEL B. LAGMAN, JR., JESSICA CASTELO DAZA, RAQUEL S. MALAÑGEN, VINCENT DG. BELMONTE and MARVIN C. RILLO.

WHEREAS, thirteen (13) airconditioning units were purchased using the funds of Councilor Jesus "Bong" C. Suntay to be donated to different barangays, public schools, police stations and health centers within District IV, namely:

1. *Barangay Bagong Lipunan ng Crame*
2. *Kamuning Police Station*
3. *Galas Police Station*
4. *Barangay Botocan*
5. *Manuel Roxas High School*
6. *Barangay South Triangle Day Care*
7. *Barangay U.P Campus Day Care*
8. *Carlos Albert High School*
9. *Krus na Ligas High School*
10. *Roxas Health Center*
11. *Krus na Ligas Kindergarten*
12. *Kamuning Health Center*
13. *Malaya Elementary School*

WHEREAS, these equipment when installed in the classrooms and day care centers would create an atmosphere more conducive to learning;

WHEREAS, these airconditioning units when installed in the Barangay Halls, Police Stations and Health Centers would provide added convenience and increase productivity of the employees working therein;

WHEREAS, it is but proper to turn over the ownership of these equipment to the recipients so that these city-owned properties maybe transferred to them without cost;

WHEREAS, a Deed of Donation will be given to the beneficiaries transferring the ownership, encumbrances and dues of the said airconditioning units thereby authorizing them to appropriate funds for the maintenance of these units from their respective budgets.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Deed of Donation for the donation of Thirteen (13) City-owned airconditioning units purchased under the funds of Councilor Jesus Manuel C. Suntay, to different barangays, public schools, police stations and health centers within District IV, this City, and authorizing the transfer of ownership of the said equipment to the recipients without cost.

RESOLVED, FURTHER, that the ownership of the said airconditioning units be transferred to the recipients through a Deed of Donation to be signed by the City Mayor Herbert M. Bautista, Councilor Jesus Manuel C. Suntay as the main proponent and the City General Services Department (CGSD) represented by Mr. Rolando P. Montiel.

RESOLVED, FUTHERMORE, that the donees be authorized to appropriate funds for the maintenance of these airconditioning units from their respective allocated budgets.

RESOLVED, FINALLY, that copies of this Resolution along with the Deed of Donation be given to the thirteen (13) recipients, the Office of the City Mayor, the City General Services Department and the Office of Councilor Jesus Manuel C. Suntay for future reference.


