RESOLUTION NO. SP- 5084, S-2010

A RESOLUTION SUPPORTING AND INTERPOSING NO OBJECTION FOR THE CONSTRUCTION OF AN EXTENSION TO THE EXISTING STEEL FOOTBRIDGE LOCATED IN FRONT OF LOYOLA HEIGHTS BARANGAY HALL CROSSING KATIPUNAN AVENUE FROM THE ATENEO DE MANILA UNIVERSITY/MIRIAM COLLEGE AT THE EXPENSE OF GEMTIN PROPERTIES, DEVELOPER OF A MIXED-USE DEVELOPMENT LOCATED AT NO. 327 KATIPUNAN AVENUE REPRESENTED BY ITS PRESIDENT MR. SIXTO ANTONIO.

WHEREAS, there is an existing steel footbridge located in front of the Barangay Hall of Loyola Heights being used by the pedestrian in crossing Katipunan Avenue from the Ateneo de Manila University/Miriam College;

WHEREAS, this existing footbridge is the only access going to the opposite side of Katipunan Avenue a mixed-use development site;

WHEREAS, Mr. Sixto Antonio, President of Gemtin Properties, the developer of the property adjacent to the above-mentioned steel footbridge proposed in his letter a request to construct at his expense, an extension of the footbridge to connect directly to the mixed-use development;

WHEREAS, the proposal is not only advantageous to the school communities of the Ateneo de Manila University and Miriam College, but also to those who will be patronizing the locators/establishments in the said project, including those who seek easy access to tricycle terminal and jeepney line;

WHEREAS, the proposal is likewise advantageous to the city government as it provides a safe and convenient access point crossing one of the city's major thoroughfares without any expenditure from the local government.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to support, as it does hereby support and interpose no objection for the construction of an extension to the existing steel footbridge located in front of Loyola Heights Barangay Hall crossing Katipunan Avenue from the Ateneo de Manila University/Miriam College at the expense of Gemtin Properties, developer of a mixed-use development located at No. 327 Katipunan Avenue represented by its president Mr. Sixto Antonio.

RESOLVED, FURTHER, that Gemtin Properties shall secure the consent and conformity of the Department of Public Works and Highways prior to the construction of the proposed extension to the existing steel footbridge.

RESOLVED, FURTHERMORE, that copies of this resolution be forwarded to the City Planning and Development Office, the City Engineering Office and Barangay Loyola Heights for information and proper action.
