RESOLUTION NO. SP- 5119 , S-2011

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED ON FEBRUARY 7, 2011 AT PZBG COMPOUND, AGHAM ROAD, BARANGAY CENTRAL, QUEZON CITY, CONSISTING OF ONE THOUSAND FIVE HUNDRED NINETY FOUR (1,594) FAMILIES AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, on February 7, 2011, a fire occurred at PZBG Compound, Agham Road, Barangay Central, Quezon City affecting 1,594 families:

WHEREAS, the City Government should extend financial assistance in order to alleviate the sad plight of the said fire victims.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the victims of fire that occurred on February 7, 2011 at PZBG Compound, Agham Road, Barangay Central, Quezon City, consisting of One Thousand Five Hundred Ninety Four (1,594) families, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, to be taken from the appropriation for Grants, Subsidies and Contributions under the 2011 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.

RESOLVED, FURTHER, that the Social Services and Development Department in coordination with Barangay Central, shall facilitate the granting of financial assistance to the said fire victims.
