RESOLUTION NO. SP-5120, S-2017

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE LUPONG TAGAPAMAYAPA MEMBER ADELAIDA B. DEUNA OF BARANGAY LIBIS, DISTRICT III, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00), AS PROVIDED FOR IN ORDINANCE NO. SP-1860, S-2008, AS AMENDED, TO BE CHARGED FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
