**A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE FLORENTINO TAN, FORMER PUNONG BARANGAY OF BARANGAY STO. CRISTO, DISTRICT 1, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.**

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the bereaved family of the late Florentino Tan, former Punong Barangay of Barangay Sto. Cristo, District 1, Quezon City, in the amount of forty thousand pesos (P40,000.00) to be charged from the appropriation for grants, subsidies and contributions under the 2011 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
