A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE RODOLFO G. MANALAD, MEMBER OF THE LUPON TAGAPAMAYAPA OF BARANGAY PAG-IBIG SA NAYON, DISTRICT 1, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

Manalad, member of the Lupon Tagapamayapa of Barangay Pag-ibig sa Nayon, District 1, Quezon City, in the amount of forty thousand pesos (P40,000.00) to be charged from the appropriation for grants, subsidies and contributions under the 2011 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
