RESOLUTION NO. SP- 5256, S-2011

A RESOLUTION STRONGLY SUPPORTING THE METRO MANILA DEVELOPMENT AUTHORITY'S "EDSA PROJECT" IN LOWERING AIR POLLUTION LEVELS ALONG EFIPANIO DELOS SANTOS AVENUE (EDSA) THROUGH THE USE OF MURALS AND THEIR BILLBOARD INSPECTION SCHEME.

WHEREAS, the Metro Manila Development Authority (MMDA) has initiated "EDSA PROJECT" which aims to lower air pollution levels along EDSA through the use of murals painted along the twenty four kilometer (24 km) highway using toxin-removing paint;

WHEREAS, EDSA Project is a collaboration among MMDA, a leading paint manufacturing company, top-rate science and art groups to put together this urban renewal initiative that will enable not only huge artworks to be posted on eight strategic locations along Metro Manila's main road artery;

WHEREAS, the said project also includes enforcement of the salient provisions of the National Building Code which specifically pertain to outdoor advertisers in setting up billboards;

WHEREAS, as part of the early submission of the said agency, billboards that are considered as earthquake hazards shall be dismantled fifteen (15) days after notice thereof;

WHEREAS, parts of EDSA falling under the exclusive jurisdiction of Quezon City are included in the said project;


WHEREAS, it is but apt for the City Council to support this plan and provide assistance on whatever way it may be deemed necessary.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to support, as it does hereby strongly support the Metro Manila Development Authority's "EDSA Project" in lowering air pollution levels along Efipanio Delos Santos Avenue (EDSA) through the use of murals and their Billboard Inspection Scheme.
