RESOLUTION NO. SP- 5259, S-2011

**A RESOLUTION REQUESTING THE SENATE THROUGH THE COMMITTEE ON CIVIL SERVICE AND PROFESSIONAL REGULATION TO FAST-TRACK THE PASSAGE OF SENATE BILL NOS. 2735 AND 2736 BOTH CONFERRING AN APPROPRIATE CIVIL SERVICE ELIGIBILITY UPON A MEMBER OF THE SANGGUNILANG BAYAN, SANGGUNILANG PANLUNGSOD, AND SANGGUNILANG PANLALAWIGAN WHO HAS SERVED THREE (3) CONSECUTIVE TERMS OF OFFICE.**

*WHEREAS, it has long been a clamor of the Municipal and City Councilors and Provincial Board Members to be conferred the appropriate Civil Service Eligibility commensurate with their terms of office;*

*WHEREAS, the same benefit or incentive had already been awarded to the Barangay Officials effectively since the enactment of the Local Government Code (R.A. 7160);*

*WHEREAS, it has long been envisioned by the Philippine Councilors League (PCL) that the said eligibility be likewise granted to its more than 16,000 councilors nationwide, and hopefully be retroactive since the effectivity of the Local Government Code;*

**RESOLVED, FURTHER,** that copies of this resolution be furnished to the Senate through the Committee on Civil Service and Professional Regulation, the Senate President, the Senate Secretary General, and the national office of the Philippine Councilors League (PCL) for their information, reference and appropriate action.
