RESOLUTION NO. SP. 5260 , S-2011

A RESOLUTION REQUESTING THE HOUSE OF REPRESENTATIVES THROUGH THE COMMITTEE ON CIVIL SERVICE AND PROFESSIONAL REGULATION TO FAST-TRACK THE PASSAGE OF HOUSE BILL NOS. 3116 AND 3678 BOTH CONFERRING AN APPROPRIATE CIVIL SERVICE ELIGIBILITY UPON A MEMBER OF THE SANGGUNIANG BAYAN, SANGGUNIANG PANLUNGSOD, AND SANGGUNIANG PANLALAWIGAN WHO HAS SERVED THREE (3) CONSECUTIVE TERMS OF OFFICE.

WHEREAS, it has long been a clamor of the Municipal and City Councilors and Provincial Board Members to be conferred the appropriate Civil Service Eligibility commensurate with their terms of office;

WHEREAS, the same benefit or incentive has already been awarded to the Barangay Officials effectively since the enactment of the Local Government Code (R.A.7160);

WHEREAS, it has been envisioned by the Philippine Councilors League (PCL) that said eligibility should likewise be granted to its more than 16,000 councilors nationwide, and hopefully be retroactive since the effectivity of the Local Government Code;

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request the House of Representatives through the Committee on Civil Service and Professional Regulation to fast-track the passage of House Bill Nos. 3116 and 3678, both conferring and appropriate Civil Service Eligibility upon a member of the Sangguniang Bayan, Sangguniang Panlungsod and Sangguniang Panlalawigan who has served three (3) consecutive terms of office.

RESOLVED, FURTHER, that copies of this resolution be furnished to the House of Representatives through the Committee on Civil Service and Professional Regulation, the Speaker of the House, the House Secretary General, and the national office of the Philippine Councilors League (PCL) for their information, reference and appropriate action.
