RESOLUTION NO. SP- 5267, S-2011

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE RODOLFO SALVATIERRA MEMBER OF THE LUPONG TAGAPAMAYAPA OF BARANGAY RAMON MAGSAYSAY, DISTRICT I, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.


