WHEREAS, the subject lot, which is relatively flat, maybe used for socialized housing;

WHEREAS, Jonathan Beltran, Filipino and of legal age, has been given a special power of attorney by Mr. David Chua to facilitate the donation intended by the owners;

WHEREAS, the City Mayor is authorized, pursuant to Section 455 of the Local Government Code of 1991, to represent his or her city in all the city's transactions and to sign documents on the city's behalf upon the authority of the Sangguniang Panlungsod.
