A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE LUPONG TAGAPAMAYAPA MEMBER ATTY. EMMANUEL O. TANSINGCO OF BARANGAY SAINT IGNATIUS, DISTRICT III, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) AS PROVIDED FOR IN ORDINANCE NO.
