RESOLUTION NO. SP- 5334 S-2011

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE KAGAWAD CARLOS P. AGUSTIN OF BARANGAY MILAGROSA, DISTRICT III, QUEZON CITY, WHO DIED OF CARDIO RESPIRATORY ARREST LAST OCTOBER 7, 1997, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE TAKEN FROM SUBSIDIES AND DONATIONS IN THE CITY GENERAL ANNUAL BUDGET FOR FISCAL YEAR 2011.

WHEREAS, the death of Barangay Kagawad Carlos P. Agustin had caused the family not only arctiety, but also difficulty in life considering that the deceased was the provider of his sick wife on her medical needs and medicines and depended particularly on his daily provisions;

WHEREAS, the deceased Kagawad has been serving as Kagawad from June 15, 1982 until 1986 and was re-elected on April 23, 1989 to May 31, 1994 in Barangay Milagrosa, thereby spending his life for almost 9 years in public services;

WHEREAS, the acceptable way for the City Government to show deep appreciation and recognize the valuable and unprecedented service of deceased Kagawad Carlos P. Agustin to the constituents of Barangay Milagrosa and at the same time show sympathy to the bereaved family is to extend financial assistance, thus, lessen the burden of losing the sole provider.
