SP-1860, S-2008, TO BE CHARGED FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.**
