RESOLUTION NO. SP- 5361, S-2011

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR HERBERT M. BAUTISTA TO EXTEND FINANCIAL ASSISTANCE IN BEHALF OF THE QUEZON CITY GOVERNMENT IN THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00) TO THE VICTIMS OF TYPHOON "SENDONC" (WASHI) AT ILIGAN CITY, CAGAYAN DE ORO CITY, AND TO SUPPORT THE RELIEF OPERATIONS OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR PROVINCES, CITIES AND MUNICIPALITIES AFFECTED DURING ITS ONSLAUGHT LAST 17 DECEMBER 2011 TO BE TAKEN FROM THE DISASTER RISK REDUCTION MANAGEMENT FUND OF THE CITY.

WHEREAS, in the morning of 17 December 2011 (Saturday) Typhoon "Sendong" (International Codename: Washi) ravaged the Southern provinces of our country;

WHEREAS, the National Disaster Risk Reduction and Management Council (NDRRMC) disclosed that, to date, a total of One Thousand Two (1,002) people have been confirmed dead and a total of 44,213 individuals, majority of them in Cagayan de Oro City are staying in 60 evacuation centers while 232,187 displaced individuals are staying outside evacuation centers;

WHEREAS, the NDRRMC recorded twelve (12) emergency incidents in six (6) regions in Mindanao and the Visayas during the typhoon's onslaught, including six (6) incidents of flooding, two (2) landslides, a road bed spillage and three (3) sea mishaps;

WHEREAS, Presidential Proclamation No. 303 dated 20 December 2011 was issued Declaring a State of Calamity and directed all departments and government agencies to implement and execute medical assistance, relief and rehabilitation work in accordance with existing operational plans and directives and orders in connection with the occurrence of calamities;

WHEREAS, Rule 18 Section 1 of the Implementing Rules and Regulations of Republic Act No. 10121 (The Philippine Disaster Risk Reduction and Management Act of 2010) provides that upon the recommendation of the LDRRMC and approval of the Sanggunian concerned, the LDRRMC may transfer the said fund to support the disaster risk reduction work of other LDRRMCs with are declared under state of calamity.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUETON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Honorable City Mayor Herbert M. Bautista to extend financial assistance in the total amount of Five Million Pesos (P5,000,000.00) to the local government units ravaged by Typhoon "Sendong" (International Codename: Washi), as follows: One Million Pesos (Php1,000,000.00) each for Iligan City and Cagayan De Oro City, Three Million Pesos (Php3,000,000.00) to support the relief operations of the Department of Social Welfare and Development for provinces, cities and municipalities affected during its onslaught last 17 December 2011 to be taken from the Disaster Risk Reduction Management Fund of the City;
