A RESOLUTION AUTHORIZING THE CITY MAYOR, HONCEABLE HERBERT M. BAUTISTA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PEDAL N PADDLE TO OPERATE A LAGOON WITH PADDLE BOATING AND BICYCLE LANE WITH MODERNIZED BICYCLES FOR RENT INSIDE THE QUEZON MEMORIAL CIRCLE.

WHEREAS, the grant of authority for the operation of such activity neither impair nor damage the City Government, but entails comfort and recreational advantage to the residents of the City;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Memorandum of Agreement with Pedal N. Paddle Inc., represented by its president, Ramon G. Singian, for the operation of a Lagoon with Paddle Boating and Bicycle Lane with Modernized Bicycles for rent inside the Quezon Memoria! Circle.
