A RESOLUTION STRONGLY SUPPORTING THE INITIATIVE OF THE DEPARTMENT OF EDUCATION (DepED) TO TAKE IMMADIATE ACTION FOR THE REHABILITATION AND REPAIR OF DILAPIDATED GABALDON SCHOOL BUILDINGS NATIONWIDE TO BE USED AS CLASSROOMS WITHOUT SACRIFICING ITS HISTORICAL SIGNIFICANCE.

WHEREAS, the Gabaldon school buildings were named after the late Congressman Isauro Gabaldon, who authored Republic Act No. 1801 widely known as GABALDON ACT, which appropriated one million pesos (P1,000,000) for the construction of school buildings in every municipality of the country;

WHEREAS, approximately three thousand (3,000) school buildings of the Gabaldon type were constructed all over the Philippines during the American colonial period. Some are still in use and others survive in precarting conditions;

WHEREAS, the rehabilitation and repair of Gabaldon school buildings nationwide is necessary to "preserve their historical significance and to address the need for more school buildings";

WHEREAS, the Department of Education and the Heritage Conservation Society (HCS) are leading efforts through the heritage school building restoration program;

WHEREAS, by restoring Gabaldon school buildings, it drives home the lesson that patrimony lives and continues to be relevant to our lives. Classes in heritage classrooms provide experiential learning or patrimony with a stronger impact than textbook instruction.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to support, as it does hereby strongly support the initiative of the Department of Education (DepEd) for the rehabilitation and repair of dilapidated Gabaldon school buildings nationwide to be used as classrooms without sacrificing its historical significance.
