RESOLUTION NO. SP- **5404**, S-2011

**A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO FIFTEEN (15) FAMILIES WHO WERE VICTIMS OF FIRE THAT OCCURRED ON JULY 13, 2011 AT WOMEN'S CLUB, BARANGAY STO. NIÑO, DISTRICT IV, QUEZON CITY, AT TWO THOUSAND PESOS (PHP2,000.00) PER FAMILY HOMEOWNER AND ONE THOUSAND PESOS (PHP1,000.00) PER FAMILY RENTER/SHARER TO BE TAKEN FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.**
