A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF QUEZON CITY TO PURCHASE FIVE (5) PARCELS OF LOT LOCATED AT DIAMOND HILLS SUBDIVISION, BARANGAY PAYATAS, QUEZON CITY FOR THE DEVELOPMENT AND EXPANSION OF THE QUEZON CITY DRUGTREATMENT AND REHABILITATION CENTER (TAHANAN).

WHEREAS, the 15<sup>th</sup> City Council approved Resolution No. SP-2911, Series of 2005 authorizing the City Mayor Feliciano R. Belmonte, Jr., to purchase a parcel of lot for the construction of a state-of-the-art rehabilitation center conducive and desirable for the treatment and rehabilitation of drug dependents;

WHEREAS, the 16<sup>th</sup> City Council amended the above-stated resolution by increasing the acquisition of one (1) lot to five (5) parcels of lot for the expansion of the Quezon City Drug Treatment and Rehabilitation Center;

WHEREAS, the five parcels of land covered by Transfer Certificates of Title Nos. RT-127771, N-295428, N-282659, N-283607 and RT-127169 are located at Dia... Hills Subdivision, Barangay Payatas, Quezon City;

WHEREAS, there is a need for the City Council to grant an authority to the City Mayor to purchase the above-mentioned properties to continue the drive against the use of illegal substances and to accommodate the growing number of drug dependents who seek rehabilitation;
