A RESOLUTION AUTHORIZING THE CITY MAYOR OF QUEZON CITY TO ENTER INTO A CONTRACT WITH SPOUSES SANTOS AND CORAZON ABIJAY AND SPOUSES DANILO AND VIVIAN VILLARAMA FOR THE PURCHASE OF PROPERTY LOCATED ALONG AVON STREET, BARANGAY FAIRVIEW, QUEZON CITY TO BE UTILIZED FOR THE IMPROVEMENT AND EXPANSION OF NORTH FAIRVIEW ELEMENTARY SCHOOL.

WHEREAS, the acquisition of the subject property will provide a venue for additional infrastructures necessary for realization of the comprehensive programs and projects of the City Government;

WHEREAS, the 17th City Council passed Resolution No. SP-4579, Series of 2009 last June 29, 2009 authorizing the Honorable Feliciano R. Belmonte, Jr. to enter into a contract with Spouses Santos and Corazon Abijay and Spouses Danilo and Vivian Villarama for the purchase of the above-mentioned property;

WHEREAS, due to the limited time given to the former Mayor and subsequent turn-over of the administration, there is a need to adopt this resolution;

WHEREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that:

"Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. xxx."

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor of Quezon City to enter into a contract with Spouses Santos and Corazon Abijay and Spouses Danilo and Vivian Villarama for the purchase of a property located along Avon Street, Barangay Fairview, Quezon City to be utilized for the improvement and expansion of North Fairview Elementary School.
