A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE JORGE M. CANONIGO, FORMER LUPONG TAGAPAMAYAPA OF BARANGAY RAMON MAGSAYSAY, DISTRICT 1, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE CHARGED FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
