A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE LUPONG TAGAPAMAYAPA NOEL C. DAGANDAN OF BARANGAY DOÑA AURORA, QUEZON CITY IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000,00) TO BE CHARGED AGAINST THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, Lupong Tagapamayapa Noel C. Dagandan of Barangay Dofta Aurora, Quezon City died last 31 March 2011;

WHEREAS, the late member of Lupong Tagapamayapa Noel C. Dagandan served Barangay Doña Aurora, Galas, Quezon City from January 1, 2010 to September 30, 2010;

WHEREAS, Ordinance No. SP-860, S-2008 provides that Barangay Officials which include Lupong Tagapamayapa are entitled to burial benefits;

WHEREAS, during his term, the late Lupong Tagapamayapa Noel C. Dagandan has faithfully and selflessly served his constituents with integrity and honesty;

WHEREAS, the late Lupong Tagapamayapa Noel C. Dagandan truly deserved the distinct honor for his exemplary deeds during his lifetime and by way of appreciation, this city must not fail to grant his bereaved family financial assistance for burial as a token of gratitude from the City Government.
