RESOLUTION NO. SP- 5441, S-2012.

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE FORMER LUPONG TAGAPAMAYAPA MEMBER JUANITO MESA OF BARANGAY ESCOPA III, DISTRICT III, THIS CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE CHARGED FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
