RESOLUTION NO. SP- 5451, S-2012

A RESOLUTION DIRECTING THE QUEZON CITY ENGINEERING DEPARTMENT TO CONSULT AND COORDINATE WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA) REGARDING ALL ROAD REPAIRS AND DRAINAGE IMPROVEMENT PROJECTS WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY.

WHEREAS, Chapter 3, Article 1, Section 25 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, defines the policy regarding intergovernmental relations between the National Government and Local Government Units;

(a) Consistent with the basic policy on local autonomy, the President shall exercise general supervision over local government units to ensure that their acts are within the scope of their prescribed powers and functions.

The President shall exercise supervisory authority directly over provinces, highly urbanized cities, and independent component cities, through the province with respect to component cities and municipalities, and through the city and municipality with respect to barangays.

- (b) National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects.
- (c) The President may, upon request of the local government unit concerned, direct the appropriate national agency to provide financial, technical, or other forms of assistance to the local government unit. Such assistance shall be extended at no extra cost to the local government unit concerned.

WHEREAS, the Department of Public Works and Highways is mandated to undertake (a) the planning of infrastructure, such as national roads and bridges, flood control, water resources projects and other public works, and (b) the design, construction, and maintenance of national roads and bridges, and major flood control systems;

WHEREAS, the Department of Public Works and Highways functions as the engineering and construction arm of the Government tasked to continuously develop its technology for the purpose of ensuring the safety of all infrastructure facilities and securing for all public works and highways the highest efficiency and quality in construction;

WHEREAS, the DPWH is currently responsible for the planning, design, construction and maintenance of infrastructure, especially the national highways, flood control and water resources development system, and other public works in accordance with national development objectives;

WHEREAS, the MMDA is also responsible for flood control and sewerage management which includes the formulation and implementation of policies, standards, rules and regulations, programs and projects for an integrated flood control, drainage and sewerage system;

WHEREAS, to help lessen the problem of flooding within the City, particularly during rainy season, the DPWH, MMDA, and the city government have to coordinate with one another in order to assure the effective delivery of services to the people.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to direct, as it does hereby direct the Quezon City Engineering Department to consult and coordinate with the Department of Public Works and Highways (DPWH) and Metropolitan Manila Development Authority (MMDA) regarding all road repairs and drainage improvement projects within the territorial jurisdiction of Quezon City.
