*WHEREAS, the grant of authority for the operation of such activity will neither impair nor damage the City Government, but entails comfort and recreational advantage to the residents of the City;*



BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Memorandum of Agreement with Madecco, Inc., represented by its President and General Manager, Engr. Melencio T. Maguinao, for the operation of a Zipline Ride and Wall Climbing Area for rent inside the Quezon Memorial Circle.
