RESOLUTION NO. SP- 5493 S-2012

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO EXTEND FINANCIAL ASSISTANCE TO THE FAMILIES AFFECTED BY FIRE THAT RAZED RESIDENTIAL AREAS ON AUGUST 3, 2011 AT BARANGAY ESCOPA I AND BARANGAY ESCOPA II DISTRICT III, THIS CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE APPROPRIATION FOR CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowered the Sangguniang Panlungsod "to adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events."

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance to the families affected by fire that razed residential areas on August 3, 2011 at Barangay Escopa I and Barangay Escopa III, District III, this City, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer which shall be taken from the appropriation for Calamity or Emergency Fund of the City Government or from any other available funds in the City Treasury.

RESOLVED, FURTHER, that the Social Services Development in coordination with the Barangay Officials of Barangay Escopa I and Barangay Escopa III shall authenticate the beneficiaries of this assistance.
