A RESOLUTION AUTHORIZING THE CITY MAYOR TO NEGOTIATE AND TO ENTER INTO A CONTRACT WITH DANILO RAMOS FOR THE PURCHASE OF A LOT AFFECTED BY THE ROAD IMPROVEMENT OF DON JULIO GREGORIO ROAD, BARANGAY SAUYO, QUEZON CITY.
