WHEREAS, Section 454 (d) of the Local Government Code of 1991 requires that appointments of heads of department and offices issued by the City Mayor shall be with the concurrence of the City Council;

WHEREAS, the confirmation of the appointment of Engr. Cabungcal as City Engineer of the Quezon City Government will complete the substantive and procedural requirements set forth by the Civil Service Rules and Regulations regarding the appointment of this nature.
