RESOLUTION NO. SP- 5527, S-2012

**A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE WHICH OCCURRED AT NO. 65 BACO STREET, BARANGAY STA. TERESITA, QUEZON CITY ON OCTOBER 19, 2011 AFFECTING MORE OR LESS TWENTY ONE (21) FAMILIES IN THE AMOUNT OF TWO THOUSAND PESOS (PHP2,000.00) PER FAMILY HOUSE OWNER AND ONE THOUSAND PESOS (PHP1,000.00) PER FAMILY HOUSE RENTER/SHARER, TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.**

*WHEREAS, on October 19, 2011 a fire occurred from unknown reasons which razed the residential houses in a compound located at No. 65-E Baco Street, Barangay Sta. Teresita, Quezon City;*

*WHEREASS, as per official record of the Social Services Development Department (SSDD), the number of victims as of this date are twenty one (21) families;*

*WHEREAS, to alleviate the plight of the fire victims, the city government should extend financial assistance to express its sympathy in their time of distress.*

Teresita, Quezon City on October 19, 2011 affecting more or less Twenty One (21) families in the amount of Two Thousand Pesos (PHP2,000.00) per family house owner and One Thousand Pesos (PHP1,000.00) per family house renter/sharer, to be charged against the appropriation for Grants, Subsidies and Contributions under the 2012 Annual Budget of the Office of the City Mayor.
