RESOLUTION NO. SP- 5534, S-2012

A RESOLUTION DONATING TWENTY FOUR (24) UNITS OF SUZUKI APV TO THE FOURTEEN (14) PUBLIC ELEMENTARY SCHOOLS AND TEN (10) PUBLIC SECONDARY SCHOOLS WITHIN DISTRICT IV OF QUEZON CITY.

WHEREAS, the Quezon City Government values the education of its minor constituents in order to transform and integrate them to be responsible and morally upright leaders of our nation;

WHEREAS, in view of the Constitutional mandate of providing quality education for our children, the Quezon City Government, within its means and resources, supports the needs of its public schools;

WHEREAS, to continue, with its commitment and to assist public schools with their daily tasks, twenty four (24) units of Suzuki APV Vehicles were purchased, through the funds of Councilor Jesus Manuel C. Suntay, to be distributed to the fourteen (14) public elementary schools and ten (10) public high schools in District IV of Quezon City, namely:

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate the twenty four (24) units of Suzuki APV to the aforementioned fourteen (14) public elementary schools and ten (10) public secondary schools within District IV of Quezon City;


