**A RESOLUTION DONATING TWO (2) UNITS OF AMBULANCE TO KAMUNING SUPER HEALTH CENTER AND TATALON HEALTH CENTER WITHIN DISTRICT IV OF QUEZON CITY.**

*WHEREAS, public health centers are established primarily to provide basic health care services to the financially challenged residents of Quezon City;*

*WHEREAS, emergency cases occasionally are being brought before these health centers but full treatment cannot be given completely due to the inadequacy of medical equipments; therefore, requiring immediate hospital attention;*

*WHEREAS, the availability of ambulance at Kamuning Super Health Center and Tatalon Health Center will be of great assistance to their operation, more particularly during emergency situations when there is a need to transfer patients to the nearest hospital;*

*WHEREAS, the two (2) units of ambulance were purchased using the funds of Councilor Jesus Manuel C. Suntay to assist these Health Centers, located in Barangay Kamuning and Tatalon, for their prompt delivery of health services;*

*WHEREAS, a Deed of Donation will be given to the beneficiaries transferring the ownership, encumbrances, and dues of the said vehicles, in so doing, authorizing them to appropriate funds for the payment of the insurance and registration of the same from their respective budgets.*

**NOW, THEREFORE,**


**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,** to donate, as it does hereby donate the two (2) units of ambulance to Kamuning Super Health Center and Tatalon Health Center within District IV of Quezon City.

**RESOLVED, FURTHER,** that the ownership of the said vehicles be transferred to the recipients through a Deed of Donation, to be signed by the Honorable City Mayor Herbert M. Bautista, Councilor Jesus Manuel C. Suntay as the main proponent, and Mr. Rolando P. Montiel representing the Office of the City General Services Department (CGSD).

**RESOLVED, FURTHERMORE,** that the recipients are authorized to appropriate funds for the payment of insurance and registration of these donated vehicles.

**RESOLVED, FINALLY,** that copies of this Resolution, along with the Deed of Donation, be given to the Office of the City Mayor, the Office of Councilor Jesus Manuel C. Suntay, the City General Services Department, and the two (2) recipients of ambulance for future reference.
