A RESOLUTION REQUESTING THE PHILIPPINE LONG DISTANCE TELEPHONE COMPANY (PLDT) AND BAYAN TELECOMMUNICATIONS, INC. (BAYANTEL) TO GIVE SPECIAL RATES TO ALL BARANGAY HALLS/FACILITIES AND DAY CARE CENTERS IN QUEZON CITY IN THEIR MONTHLY TELEPHONE BILLS.

WHEREAS, Section 384 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "the barangay serves as the primary planning and implementing unit of government policies, plans, programs, projects and activities in the community, and as a forum wherein the collective views of the people may be expressed, crystallized and considered, and where disputes may be amicably settled";

WHEREAS, parallel to this mandated tasks, barangays were able to put-up barangay halls and other facilities to serve as its office and venue of activities;

WHEREAS, portion of the annual barangay budget is set aside for the payment of the monthly telephone bills;

WHEREAS, the primordial intention of a barangay is to deliver basic services and never for the purpose of gain or profit;

WHEREAS, special rates in the telephone bills may give them an avenue for other projects/undertakings beneficial to the residents, thus, this resolution.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request the Philippine Long Distance Telephone Company (PLDT) and Bayan Telecommunications, Inc. (BayanTel), to give special rates to all Barangay Halls/facilities and Day Care Centers in Quezon City in their monthly telephone bills.
