RESOLUTION NO. SP. 5569 S-2012

A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE A PARCEL OF LAND WITH IMPROVEMENTS SITUATED AT LOT 8 BLOCK 5 DON ANTONIO STREET, VILLA BEATRIZ SUBDIVISION, BARANGAY MATANDANG BALARA, QUEZON CITY, TO BE THE PERMANENT HEALTH CENTER OF BARANGAY MATANDANG BALARA, DISTRICT III, THIS CITY.

WHEREAS, the Sangguniang Barangay of Barangay Matandang Balara adopted a resolution, entitlted, "Barangay Council Resolution Urging His Honor, Mayor Herbert M. Bautista, to Purchase a Parcel of Land with Improvements Situated at Lot 8 Block 5 Don Antonio Street, Villa Beatriz Subdivision, Barangay Matandang Balara, Quezon City, to be the Permanent Health Center of Barangay Matandang Balara, District III, Quezon City";

WHEREAS, the relocation structure of Old Balara Health Center located along Tandang Sora Avenue corner Capitol Hills Drive is not sufficient to serve as the permanent health center of Barangay Matandang Balara because of its small space which is only thirty square meters (30 sq.m.) based on the findings of the Quezon City Planning and Development Office (QCPDO) on 15 January 2010;

WHEREAS, a parcel of land with improvements owned by Mr. Orlando L. Benipayo located at Lot 8 Block 5 Don Antonio Street, Villa Beatriz Subdivision, Barangay Matandang Balara, this City, containing an area of three hundred sixty-seven square meters (367 sq.m) and covered by TCT No. N-237453 is presently for sale;

WHEREAS, there is a need to purchase the said land in order to serve as the permanent health center of Barangay Matandang Balara so that there will be a better and more convenient place for maternal and childcare program, including dental, TB control program, pap smear for women and microscopy/laboratory center, thus, avoid crowding and the passing of communicable diseases.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista, to purchase a parcel of land with improvements situated at Lot 8 Block 5 Don Antonio Street, Villa Beatriz Subdivision, Barangay Matandang Balara, Quezon City, to be the permanent health center of Barangay Matandang Balara, District III, this City.
