RESOLUTION NO. SP- 5594 , S-2012

**A RESOLUTION AUTHORIZING THE BARANGAY COUNCIL OF SACRED HEART, QUEZON CITY, TO UTILIZE 70% OF THEIR DULY ALLOCATED AND APPROVED 2011 CALAMITY FUND AMOUNTING TO THREE HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED TWENTY TWO PESOS (PHP358,422.00) FOR THE CAPABILITY ENHANCEMENT OF THE DISASTER RISK REDUCTION MEASURES OF THEIR BARANGAY.**

*WHEREAS, it is a declared principle of the Republic of the Philippines, as provided for in the 1987 Constitution, that the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;*

*WHEREAS, the Barangay Council of Sacred Heart deemed it proper to organize a committee known as the Barangay Disaster Risk Reduction Management Council (BDRPMC) in order to orient its residents of the importance of disaster risk preparations as well as mental alertness whenever faced with such occurrences;*

*WHEREAS, pre-disaster preparedness program specifically purchase of live-saving and safety enabling devices and related rescue/recovery tools and equipment is allowed under DILG-NCR Regional Memorandum Circular No. 2011-012;*

*WHEREAS, the Barangay Council of Sacred Heart had approved Barangay Resolution No. 157, Series of 2011 urgently requesting the Honorable City Mayor Herbert M. Bautista, through City Council Resolution, to allow them to utilize 70% of the duly allocated and approved 2011 calamity fund to support their disaster risk reduction measures;*

*BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Barangay Council of Sacred Heart, Quezon City, to utilize 70% of their duly allocated and approved 2011 calamity fund amounting to three hundred fifty eight thousand four hundred twenty two pesos (Php358,422.00) for the capability enhancement of the disaster risk reduction measures of their barangay.*
