RESOLUTION NO. SP- 5605, S-2012

**A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO EXTEND FINANCIAL ASSISTANCE TO THE THIRTY NINE (39) FAMILIES AFFECTED BY FIRE THAT RAZED A RESIDENTIAL AREA ON FEBRUARY 26, 2012 AT BARANGAY LOYOLA HEIGHTS, DISTRICT III, THIS CITY AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.**



**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,** to urge, as it does hereby strongly urge the City Mayor, Honorable Herbert M. Bautista to extend financial assistance to the Thirty Nine (39) families affected by fire that razed a residential area on February 26, 2012 at Barangay Loyola Heights, District III, this City at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer which shall be taken from the Calamity or Emergency Fund of the City Government or from any other available funds in the City."

**RESOLVED, FURTHER,** that the Social Services Development Department in coordination with the Barangay Officials of Barangay Loyola Heights shall authenticate the beneficiaries of this assistance.
