A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MAYOR HERBERT M. BAUTISTA TO OPEN A FOREIGN LETTER OF CREDIT WITH LANDBANK OF THE PHILIPPINES-QUEZON CITY HALL BRANCH TO DBS BANK LIMITED WITH BUSINESS ADDRESS AT 6 SHENTON WAY NO. 02-02, DBS BUILDING TOWER ONE, SINGAPORE, 068809, IN FAVOR OF MAIN EMPIRE COMPANY LIMITED REPRESENTED BY MR. LEON B. TIO, PRESIDENT, TKC HEAVY INDUSTRIES CORPORATION FOR THE IMPORTATION OF ONE (1) UNIT MOBILE WALKING EXCAVATOR, IN THE AMOUNT OF TWENTY THREE MILLION ONE HUNDRED FIFTY THOUSAND SIX HUNDRED EIGHTY FOUR PESOS (P23,150,684.00) SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS PERTINENT THERETO.

WHEREAS, the City Engineering Department is requesting for the procurement of a Walking Excavator to be utilized for the City's road works and other improvements that are needed for the City's infrastructure;

WHEREAS, the Quezon City Government has an outstanding deposit under its account with the Land Bank of the Philippines-Quezon City Branch;

WHEREAS, the Quezon City Government intends to import One (1) Unit Mobile Walking Excavator Model: Batemag P.70 2WD with the One (1) Unit Hydraulic Hammer, One (1) Unit Universal Grab and One (1) Unit Hydraulic Quick Coupler to be used in various road works and improvements implemented by the City;

WHEREAS, Main Empire Company Limited, represented by Mr. Leon B. Tio, President of TKC Heavy Industries Corporation is the exclusive distributor of Mobile Walking Excavator Model: Batemag P.70 2WD in the Philippines;

WHEREAS, the City Treasurer certified the availability of funds of the Quezon City Government to import One (1) Mobile Walking Excavator being an essential tool for City infrastructure projects and other flood control measures;

WHEREAS, the Letter of Credit is an essential requirement to exempt the Quezon City Government from the taxes imposed by the Bureau of Customs and other related documentary requirements for shipping.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista to open a foreign Letter of Credit with Landbank of the Philippines-Quezon City Hall Branch to DBS Bank Limited with business address at 6 Shenton Way No. 02-02, DBS Building Tower One, Singapore, 068809, in favor of Main Empire Company Limited represented by Mr. Leon B. Tio, President, TKC Heavy Industries Corporation for the importation of one (1) unit mobile walking excavator, in the amount of Twenty Three Million One Hundred Fifty Thousand Six Hundred Eighty Four Pesos (Php 23,150,684.00) subject to existing laws, rules and regulations pertinent thereto.

RESOLVED, FURTHER, that the release of payment shall be subject to the issuance of Certificate of Acceptance after inspection and evaluation to be conducted by the City Engineering Department.

RESOLVED, FURTHERMORE, that the Letter of Credit shall be valid for a period of One Hundred Twenty (120) Days upon receipt of the Letter of Credit.
