*WHEREAS, the Quezon City government under the administration of Honorable Herbert M. Bautista laid the foundation of disaster risk reduction in the City and its constituents by continuously providing support to the Barangays;*

*WHEREAS, the City General Service Department (CGSD) recommended the transfer without cost of one (1) unit Isuzu NKR Water Tender (Tanker) from the Quezon City Government to Barangay Krus na Ligas, Quezon City considering the fact that the procurement of the said vehicle contribute savings to the City and barangay government;*

*WHEREAS, by donating the said unit to Barangay Krus na Ligas, the Quezon City Government will reduce its expenditure such as, but not limited to, petroleum and lubricants, insurance coverage, maintenance and annual registration fees of the Water Tender (Tanker) and make substantial savings for the City and the barangay government;*

*WHEREAS, the Honorable Mayor Herbert M. Bautista approved the recommendation of the City General Service Department (CGSD) to transfer One (1) Unit Isuzu NKR Water Tender (Tanker) to Barangay Krus na Ligas.*
